Family Educational Rights and Privacy Act (FERPA)

If the student wants the Financial Aid Office to be able speak to anyone (including a parent) regarding the financial aid, the student must complete an electronic FERPA release form on Self-Service.

2. Click on the “User Options” menu and then on “FDU FERPA Release”
3. Click on “Add a Contact”
4. Fill in the contact’s name, relationship, and the start date (the date that this will become effective).
5. The expiration date is optional and can be changed at any point.
6. Click “Save”

More about Direct Loans

Loans need to be repaid. Repayment typically begins 6 months after the student graduates or drops below half-time

Subsidized loans and unsubsidized loans have the same interest rate (6.533%), but the government pays the interest on the subsidized loan while the student is in school.

You can make interest-only payments on the unsubsidized loan while the student is enrolled. Make those arrangements with your loan servicer.

Need to borrow an additional loan?

Parent PLUS Loan: Parent Only (no student borrowers)

Parent applies at www.studentaid.gov

9.083% interest for 2024-2025a and Loan fee is 4.228%

Private Loan: Parent or Student (with Co-signer)

Check out: www.elmselect.com/v4/school/630/program-select

Make sure your application is submitted and approved before August 15th or before the student is moving to campus (if earlier).

Consider an annual loan: August 2024 – May 2025

Don't forget about fees!

FAQ: Can Dropping Classes Impact Aid Eligibility?

YES!

- **FDU Grants and Scholarships** require a student be enrolled full-time (12+ credits)
- **NJ Tuition Aid Grant** requires full-time enrollment
- **Federal Pell Grant** eligibility is pro-rated if a student drops below 12 credits
- **Direct loans and PLUS loans** – require half-time enrollment (6+ credits)

Have the student check with us if they are thinking of dropping courses!

FAQ: Is the Aid Guaranteed for 4 Years?

FDU Merit Awards will renew for a total of four years if the student maintains the required GPA (3 years for transfer students)

Fairleigh Dickinson University Grants and **federal and state financial aid** will renew if the student files a FAFSA by the April 15th deadline and continues to meet eligibility criteria

Student must make **Satisfactory Academic Progress (SAP)** to retain eligibility

This is a federal requirement. SAP status is evaluated after every semester.

- * 2.0 GPA

- * Successfully complete 2/3 of credits attempted

FAQ: Is there a limit on the number of semesters I can receive my financial aid?

YES!

- **FDU grants and scholarships:** 8 semesters for freshman admits (different limit for transfer students)
- **Federal Pell Grant:** 12 semesters
- **NJ Tuition Aid Grant:** 9 semesters
- **Direct loans:** \$31,000 total borrowing for dependent students

Frequently Asked Questions Cont.

When can I expect a refund?

Loans will not disburse to your account until late September - after the add/drop period. Make sure you have adequate resources until then.

There has been a change in my family's financial situation. What do I do?

Contact the Financial Aid Office. You will be asked to complete a Change in Financial Circumstances Review Request Form and supply supporting documentation
